A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO CONTRACTUAL RENEWAL #1 WITH THE JOINT VENTURE OF DOBBS, RAM & COMPANY AND PUBLIC RESOURCES ADVISORY GROUP FOR FINANCIAL ADVISORY SERVICES FOR THE CITY OF ATLANTA IN REGARD TO THE FINANCIAL PLANNING AND MARKETING OF BOND ISSUES; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta's Chief Financial Officer issued a Request for Proposal for financial advisory services on March 18, 2002, pursuant to Code Section 2-992; and

WHEREAS, the Joint Venture of Dobbs, Ram & Company and Public Resources Advisory Group had the highest combined score of those proposing to perform those services; and

WHEREAS, the Council authorizing a contractual agreement with the Joint Venture of Dobbs, Ram & Company and Public Resources Advisory Group for financial advisory services by Resolution 02-R-0813, for a period of one year with two renewals of one year each; and

WHEREAS, the Joint Venture of Dobbs, Ram & Company and Public Resources Advisory Group provided the services required under the Agreement for Financial Advisory Services in a professional manner; and

WHEREAS, the Chief Financial Officer recommends that the City exercise the first renewal option under this agreement.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby resolves that the Mayor and Chief Financial Officer be and are authorized to enter into a Renewal #1 to the contractual agreement between the City of Atlanta and the Joint Venture of Dobbs, Ram & Company and Public Resources Advisory Group for financial advisory services.



BE IT FURTHER RESOLVED that the cost of such financial advisory services shall be paid from the proceeds of the respective bond issues on which the Joint Venture of Dobbs, Ram & Company and Public Resources Advisory Group provides financial advisory services.

BE IT FINALLY RESOLVED that the fees associated with this renewal contract shall continue to be as follows:
