A RESOLUTION IN SUPPORT OF THE ATLANTA HOUSING AUTHORITY'S (AHA) APPLICATION FOR FEDERAL FISCAL YEAR 2004 HOPE VI FUNDING FOR THE REVITALIZATION OF THE MCDANIEL GLENN COMMUNITY

WHEREAS, the U. S. Department of Housing and Urban Development (HUD) has ambitiously sought to transform the nation's obsolete and severely distressed public housing through the use of Urban Revitalization Demonstration or HOPE VI programs;

WHEREAS, on October 21, 2003, HUD issued a Notice of Funding Availability (NOFA) for grants to support HOPE VI Revitalization and Demolition;

WHEREAS, the U. S. Congress has appropriated, and HUD is making available, \$447,750,000 in Federal Fiscal Year 2004 (application due January 20, 2004) to enable revitalization and transformation of the physical site of severely distressed public housing developments and the social dynamics of life for low income residents of these sites;

WHEREAS, funding under the Federal Fiscal Year 2004 HOPE VI program will be extremely competitive as all 3,400 public housing authorities across the nation are eligible to apply;

WHEREAS, funds will be awarded to public housing authorities that demonstrate a strategy that will not only revitalize their targeted developments, but will also help to revitalize the surrounding neighborhood, such as the Mechanicsville neighborhood;

WHEREAS, AHA is submitting an application for \$20 million under the Federal Fiscal Year 2004 HOPE VI program for the revitalization of the McDaniel Glenn Community;

WHEREAS, the City of Atlanta has been engaged in vigorous and aggressive efforts to revitalize the Mechanicsville neighborhood, and to that end, the City of Atlanta is committed to working with AHA to develop a comprehensive master plan encompassing the McDaniel Glenn community and the surrounding Mechanicsville neighborhood; and

WHEREAS, the receipt of \$20 million in HOPE VI grant funds will enable AHA, the City of Atlanta, and the McDaniel Glenn residents to immediately begin the revitalization of the McDaniel Glenn Community, the transformation of resident's lives and opportunities, and stimulate additional development in the Mechanicsville neighborhood.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:

That the Council of the City of Atlanta, Georgia hereby commends AHA for its initiative in taking advantage of the funding opportunity afforded by the Federal Fiscal Year 2004 HOPE VI Program, and fully supports AHA in the submission of a Federal Fiscal Year 2004 HOPE VI Application for the revitalization of the McDaniel Glenn Community and the transformation of the lives of the residents, with the understanding that such funding, if received, will serve as the catalyst for the revitalization of McDaniel Glenn and will support the City of Atlanta's redevelopment plans for the surrounding communities.
