AN ORDINANCE TO RE-NAME THE SOUTHEAST ATLANTA RECREATION CENTER TO ROSEL J. FANN RECREATION CENTER; AND FOR OTHER PURPOSES.

WHEREAS, Mrs. Rosel J. Fann has served NPU-Z and southeast Atlanta well for over 30 years; and

WHEREAS, Mrs. Rosel J. Fann has provided outstanding leadership in the community; and

WHEREAS, Mrs. Rosel J. Fann is currently the chairperson of NPU-Z and is presently employed as a Community Resources Coordinator at Southside Industrial Park; and

WHEREAS, it would be fitting to honor Mrs. Rosel J. Fann for her years of outstanding services, commitment, and contribution to the community.

WHEREAS, Mrs. Rosel J. Fann does not meet the age requirement of 75 as stated in Section 2-2. Naming of public facilities and streets in honor of persons.

NOW, THEREFORE, IT IS ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the paragraph in Section 2-2. Naming of public facilities and streets in honor of persons, which reads:

“No public building, park, park facility, public street, right-of-way, bridge or similar public facility shall be named after or in honor of any person, unless such person has attained the age of 75 years or has been deceased at least 30 days or such naming is a condition of a gift or grant accepted by the city.” is hereby **waived**.

Section 2: That the Southeast Atlanta Recreation Center be re-named to ROSEL J. FANN RECREATION CENTER.

Section 3: That all ordinances or parts of ordinances in conflict herewith are hereby rescinded.
