**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA,
GEORGIA, as follows:**

Section 1: That the City of Atlanta **SUPPORTS** the following legislation that is presently before the 2004 Georgia General Assembly:

House Bill 1155 which enhances the penalties for a motorist who collides with a motorcycle, wheelchair, pedestrian or bicyclist in the right of way.

Senate Bill 425 which removes the requirement that federal transportation dollars used for interstate highways be balanced among the various congressional districts.

Solid Waste Trust Fund – the restoration of full funding.

SPLOST – Support **Georgia Municipal Association's** position on the equitable division of SPLOST revenues

Section 2: That the Municipal Clerk is hereby directed to forward a copy of this Resolution to the Governor, Lieutenant Governor, and all members of the 2004 Georgia General Assembly.
