**A RESOLUTION RECOGNIZING THAT THE MAYOR OR HER
DESIGNEE IS INVESTIGATING THE POSSIBLE USES OF THE
PROPERTY KNOWN AS CITY HALL EAST, REQUIRING THE
PRESENTATION OF ALL PROPOSALS TO THE CITY COUNCIL
AND FOR OTHER PURPOSES.**

WHEREAS, the City of Atlanta has been the owner of certain property known as City Hall East since 1991; and

WHEREAS, the Executive Branch has solicited proposals to investigate the possibility of declaring City Hall East as surplus property and the future development thereof; and

WHEREAS, the City is open to a variety of approaches to finance the possible redevelopment, including but not limit to, a straight sale, a public/private partnership, continuing use by the City as a tenant, or any combination of the above.

THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that the Council recognizes that the Mayor or her designee is investigating possible future use of the property known as City Hall East, including but not limited to the economic incentive programs, sale of the property, public/private partnership or any combination of the above; and

BE IT FINALLY RESOLVED that the Mayor or her designee shall present in detail all proposals received from the solicitation to the Atlanta City Council no later than April 5, 2004.
