

**AN ORDINANCE BY COUNCILMEMBER
AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE**

**AN ORDINANCE TO AMEND ARTICLE "V",
CLASSIFICATION PLAN, SECTION 114-477, OF THE CODE
OF ORDINANCES, CITY OF ATLANTA, GEORGIA, SO AS TO
ABOLISH FILLED POSITIONS, CREATE POSITIONS AND
CLASSIFICATIONS; AND FOR OTHER PURPOSES.**
