A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE RENEWAL AGREEMENT NO. 1 FOR FC-7491-02, INMATE PHYSICIAN SERVICES (RFP) WITH ATLANTA INTERNAL MEDICINE, P.C. D/B/A DR. WILLIAMS AND WOODS IN AN AMOUNT NOT TO EXCEED \$171,600.00 ANNUALLY TO PROVIDE PHYSICIAN SERVICES FOR PRETRIAL, FEDERAL AND SENTENCED INMATES; ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND, ACCOUNT AND CENTER NUMBER: 3P02 524001 I21W02CL9999.

WHEREAS, the City of Atlanta did solicit Request for Proposals from qualified consulting firms for FC-7491-02, Inmate Physician Services (RFP) to provide physician services for pretrial, federal and sentenced inmates on behalf of the Department of Corrections; and

WHEREAS, said Agreement contained an option to renew for two (2) additional one (1) year periods; and

WHEREAS, the Chief of the Department of Corrections and the Chief Procurement Officer have recommended that Renewal Agreement No. 1 be executed for a period of one (1) year.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and hereby authorized to execute on behalf of the City of Atlanta Renewal Agreement No. 1 for FC-7491-02, Inmate Physician Services with Atlanta Internal Medicine d/b/a Drs. Williams and Woods in an amount not to exceed \$171,600.00 to provide physician services for pretrial, federal and sentenced inmates.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer be and is hereby directed to prepare said Renewal Agreement No. 1 for execution by the Mayor, to be approved as to form by the City Attorney.

BE IT FURTHER RESOLVED, that said Renewal Agreement No. 1, shall not become binding on the City of Atlanta, and the City of Atlanta shall incur no liability nor obligation thereunder until the same has been signed by the Mayor and delivered to the contracting party.

BE IT FINALLY RESOLVED, that all contracted work shall be charged to and paid from Fund, Account and Center Number: 3P02 524001 I21W02CL9999.
