WHEREAS, the City is considering legislation that will substantially alter the code as it relates to vending in the public right of way; and

WHEREAS, the evaluation process, including public hearings, will not be completed prior to the time the site selection process must be initiated to insure issuance of new permits before the expiration date of the current permits.

WHEREAS, there is a likelihood that as a result of the vending code review, the timing and nature of the permitting process will be altered possibly resulting in a need to reissue permits; and

WHEREAS, having to reissue permits will result in an unnecessary and duplicitous manpower hours and use of resources; and

WHEREAS; the authority to issue vending permits falls under the City's police power and avoidance of unnecessary expenditures is consistent with public policy; and

WHEREAS, the City will maintain the option to assess a pro rated permit fee in proportion to the additional time granted to current permit holders by virtue of the extension.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA:

Section 1:

That any person granted a permit to vend on public property pursuant to **Chapter 30**, Article XXIII of the City of Atlanta Code of Ordinances during the calendar year 2003, which is scheduled to expire on March 31, 2004, shall remain valid through June 30, 2004. All current permit holders subject to this extension shall be required to pay a prorated permit fee in proportion to the length of the extension.


