A RESOLUTION APPOINTING THE CITY OF ATLANTA MUNICIPAL CLERK TO ACT AS THE MUNICIPAL ELECTION SUPERINTENDENT FOR A CITY OF ATLANTA SPECIAL ELECTION TO BE HELD TO FILL THE VACATED CITY COUNCIL PRESIDENT SEAT; AND IF NECESSARY TO FILL ANY VACATED COUNCIL SEAT, DISTRICT OR AT-LARGE POST; AUTHORIZING THE CLERK, IN HER CAPACITY AS MUNICIPAL ELECTION SUPERINTENDENT, TO CALL SAID SPECIAL ELECTION ON TUESDAY, JULY 20, 2004, AUTHORIZING THE MUNICIPAL CLERK TO PROVIDE SERVICES IN REGARDS TO QUALIFYING CANDIDATES FOR ELECTION TO SAID SEATS, AND TO UNDERTAKE ANY OTHER SUCH DUTIES AS ARE NECESSARY TO ACCOMPLISH THE HOLDING OF SAID SPECIAL ELECTION; SETTING THE DATE, TIME AND FEE FOR THE QUALIFYING OF CANDIDATES; AND FOR OTHER PURPOSES.
