**AUTHORIZING THE MAYOR OR HER DESIGNEE TO ACCEPT ON BEHALF OF THE ATLANTA FIRE DEPARTMENT DONATIONS IN THE AMOUNT OF \$2,500.00 FOR THE PURPOSE OF PURCHASING SMOKE ALARMS IN SUPPORT OF THE ATLANTA SMOKE ALARM PROGRAM (ASAP) AND FOR OTHER PURPOSES.**

**Whereas**, the Atlanta Fire Department has taken the initiative to implement the Atlanta Smoke Alarm Program; and

**Whereas**, the objective of the program is to install a smoke alarm into the home of any Atlanta citizen who need one.

**Whereas**, smoke alarms have been known to save the lives of homeowners, who were notified in time that damage was imminent; and

**Whereas**, it is the mission of the Atlanta Fire Department to protect lives and property from disastrous incidents and when such incidents do occur to mitigate and reduce the resulting damages; and

**Whereas**, the funds (\$2,500.00) from these donations will be used solely for the purchase of smoke alarms for the benefit of the residents of the City of Atlanta.

Now, therefore, be it resolved by the Council of the City of Atlanta, Georgia as follows:

**Section 1.** The Mayor or her designee allow the Atlanta Fire Department to accept donations in the amount of \$2,500.00 for the purchase of smoke alarms from the following donors:
