AN ORDINANCE

AN ORDINANCE AMENDING THE 2004 (2000 G.O. REFERENDUM QUALITY OF LIFE BOND FUND) BUDGET BY TRANSFERRING FROM AND TO APPROPRIATIONS IN THE AMOUNT OF \$384,000.00 TO FUND THE MCCLENDON AVENUE STREET RESURFACING PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, certain street resurfacing and reconstruction projects were authorized in the 2000 G.O. Bond Referendum Quality of Life legislation, and funds were appropriated for those projects accordingly; and

WHEREAS, the McClendon Avenue Street Resurfacing project from Lakeshore Drive to Moreland Avenue is a project listed in the Quality of Life program, but not receiving first bond issue funding; and

WHEREAS, a traffic calming project is currently underway on this corridor and coordination with the resurfacing project is desired; and

WHEREAS, this resurfacing project will provide better access for community residents, emergency and utility vehicles which service the area; and

WHEREAS, the Department of Public Works in agreement with the Councilmember representing District 6 would like to complete this project as soon as possible and is willing to re-prioritize the Lenox Road Bridge Replacement project; and

WHEREAS, funds for the Lenox Road Bridge Replacement project will be re-appropriated with the second bond issue allowing such first bond issue funds to be allocated to the construction of the McClendon Avenue Street Resurfacing project.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That the 2004 (2000 G.O. Referendum Quality of Life Bond Fund) Budget is amended as follows:

TRANSFER FROM APPROPRIATIONS
