AN ORDINANCE TO TRANSFER \$ 2,000.00 FROM
DISTRICT NINE (9) COUNCIL MEMBER EXPENSE ACCOUNT
TO CONTRIBUTE TO THE BOLTON ROAD-MOORES MILL
LCI PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, by Resolution 02-R-1328 the City of Atlanta adopted the Bolton Road-Moores Mill Livable Communities Initiative (LCI) Project on December 15, 2002; and

WHEREAS, the Bolton Road-Moores Mill LCI Project has been approved by the Atlanta Regional Commission for an implementation grant in the amount of \$20,000.00 to study Industrial Traffic Patterns in this LCI area; and

WHEREAS, several public and private groups in the neighborhood have also donated \$20,000.00 as the matching funds for the grant; and

WHEREAS, funds are available in District 9 council member's expense account to assist in the implementation of the Bolton Road-Moores Mill LCI Project; and

WHEREAS, the council person has decided to contribute to the project.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA,
HEREBY ORDAINS as follows:
