



A SUBSTITUTE ORDINANCE

AN ORDINANCE AMENDING THE 2004 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$25,000 FOR AN AWARD BY THE BUREAU OF ALCOHOL, TOBACCO FIREARMS AND EXPLOSIVES FOR POLICE OVERTIME INCURRED WHILE ASSISTING THE BUREAU IN THE PSN/HIDTA TASK FORCE, AND FOR OTHER PURPOSES

WHEREAS, the Bureau of Alcohol, Tobacco, Firearms and explosives has granted \$25,000 to the Atlanta Police Department to cover police officer overtime costs associated with joint operations related to the High Intensity Drug Trafficking and Project Safe Neighborhoods programs, and

WHEREAS, the Atlanta Police Department can deploy officers in conjunction with these efforts to sharply reduce crimes and violence, and

WHEREAS, partnering with the Bureau of Alcohol, Tobacco, Firearms and Explosives has proven to be an effective crime reduction strategy, and

WHEREAS, the Budget Commission for the City of Atlanta has recommended increasing estimated receipts in the Intergovernmental Grant Fund by \$25,000

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA

Section one: that the (Intergovernmental Grant Fund) budget, Department of Police be amended as follows:



Section two: that no matching funds are required as part of this agreement.




Section three: that all ORDINANCES or parts of ORDINANCES in conflict with the provisions herein are hereby repealed.

Dear Chief Pennington:

As outlined in the attached Memorandum of Agreement (MOA) with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), ATF agrees to reimburse Atlanta Police Department overtime salary costs incurred while assisting ATF in a task force described in the attached MOA.

For fiscal year 2004, these reimbursements to your agency will not exceed \$25,000. This amount may be modified in writing by ATF. No task force personnel may be paid in excess of \$14,000 per task force member through September 30, 2004. All funds will expire on September 30, 2004.

This authority is pursuant to the provisions of the MOA, which provides for the reimbursement of overtime salary costs of State or local law enforcement agencies incurred while assisting ATF in joint law enforcement operations.


