AN ORDINANCE TO ANTICIPATE AND APPROPRIATE FUNDS IN THE AMOUNT OF \$40,000 FROM THE STATE OF GEORGIA, CHILDREN AND YOUTH COORDINATING COUNCIL FOR THE CONTINUATION OF THE UNDERAGE DRINKING PREVENTION PROGRAM IN THE CITY OF ATLANTA

WHEREAS, the State of Georgia, Children and Youth Coordinating Council has awarded the Atlanta Police Department a continuation of the grant used for the prevention of underage drinking in the City of Atlanta, and

WHEREAS, the Atlanta Police Department has utilized its License and Permits unit to extend it's enforcement of underage drinking laws at those establishments that serve alcohol, and

WHEREAS, the Budget Commission of the city of Atlanta has recommended increasing the estimated receipts in the intergovernmental grant fund by \$40,000.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA

Section One: that the (Intergovernmental Grant Fund) Budget, Department of Police, be and is hereby amended as follows:


