AN ORDINANCE TO AMEND THE 1982 CITY OF ATLANTA ZONING ORDINANCE, AS AMENDED, SO AS TO PERMIT CHUCHES, SYNAGOGUES, TEMPLES, MOSQUES AND OTHER RELIGIOUS WORSHIP FACILITIES AS PERMITTED PRINCIPAL USES AND STRUCTUIRES IN THE PD-MU (PLANNED DEVELOPMENT-MIXED USE) AND PD-OC (PLANNED DEVELOPMENT-OFFICE COMMERCIAL) DISTRICTS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1. That Section 16-19B.003 (Planned Development-Mixed Use, Permitted Principal Uses and Structures) of the 1982 City of Atlanta Zoning Ordinance as amended, is hereby further amended by adding a new paragraph (16) which shall read as follows:

“(16) Churches, Synagogues, Temples, Mosques and Other Religious Worship Facilities”

SECTION 2. That Section 16-19C.003 (Planned Development-Office Commercial, Permitted Principal Uses and Structures) of the 1982 City of Atlanta Zoning Ordinance, as amended, is hereby further amended by a new paragraph (15) which shall read as follow”

“(15) Churches, Synagogues, Temples, Mosques and Other Religious Worship Facilities”

SECTION 3. That all ordinances or parts of ordinances in conflict with the terms of this ordinance are hereby repealed.


