**A SUBSTITUTE ORDINANCE AMENDING THE 2004 (AIRPORT REVENUE FUND BUDGET AND AIRPORT RENEWAL AND EXTENSION FUND BUDGET IN THE AMOUNT OF \$130,822.00 AND 567,958.00 RESPECTIVELY FOR THE PURPOSES OF FUNDING NEWLY CREATED POSITIONS IN THE DEPARTMENT OF AVIATION AS SET FORTH IN ORDINANCE NUMBER 04-O-1812.**

**WHEREAS**, the Department of Aviation is seeking to strategically strengthen its workforce with the creation of several new positions; and

**WHEREAS**, the Department of Aviation wishes to attract and retain experienced personnel; and

**WHEREAS**, the Department of Aviation has completed a Salary Survey of the nations top 30 airports resulting in the identification of a more competitive salary structure; and

**WHEREAS**, the Department of Aviation has requested certain salaries be aligned with the creation of new positions; and

**WHEREAS**, it is now necessary to adjust budget appropriation levels to provide funding through the remainder of the year for the newly created positions.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS** as follows:


