A RESOLUTION AUTHORIZING THE MAYOR OR HER DESIGNEE TO EXECUTE AN AGREEMENT WITH THE ATLANTA AIRLINES TERMINAL CORPORATION (AATC) FOR THE REMOVAL AND REPLACEMENT OF THE CONCOURSE E EXPANSION JOINT AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT, FOR A COST TO THE CITY NOT TO EXCEED \$1,134,617.00 TO BE CHARGED TO AND PAID FROM FUND ACCOUNT CENTER NUMBER 2H21 523001 R21001 (RENEWAL AND EXTENSION FUND); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (hereinafter "City"), as owner and operator of the Hartsfield-Jackson Atlanta International Airport (hereinafter "the Airport") has entered into certain Lease Agreements, dated March 22, 1978, with various airlines serving the Airport (hereinafter "Contracting Airlines"), which cover the planning, design, development, construction, maintenance, and operation of the Central Passenger Terminal Complex and other Air Operations Area facilities (hereinafter "AOA") at the Airport, with the City having responsibility for capital replacement items on the AOA; and

WHEREAS, the Contracting Airlines formed Atlanta Airlines Terminal Corporation (hereinafter "AATC") to manage and operate the jointly leased and common use areas of the Airport, including aircraft parking areas and gates on the AOA, on behalf of the Airlines and the City collectively; and

WHEREAS, safety concerns for Airport employees and support staff have caused the need to remove and replace the expansion joint surrounding the Concourse E International Terminal due to excessive wear and widening and failure to provide an even working surface; and

WHEREAS, to facilitate a safer working area for aircraft, airline passengers, crews and support staff, contractors, and other Airport staff; and

WHEREAS, it is appropriate for AATC to remove and replace the expansion joint at Concourse E as they routinely coordinate logistics issues concerning airline movement and parking at the concourses; and

WHEREAS, the removal and replacement of the Concourse E expansion joint will be reimbursed by the City, as established in Section 6.01B of the March 22, 1978 CPTC Lease agreement with the Contracting Airlines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ATLANTA, GEORGIA, that the Mayor or her designee be and hereby authorized to execute on behalf of the City of Atlanta a Reimbursable Agreement with AATC for the removal and replacement of the Concourse E Expansion Joint at Hartsfield-Jackson Atlanta International Airport, with the reimbursement of the cost thereof by the City to AATC up to a total amount not to exceed \$1,134,617.00.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from Fund Account Center Number 2H21 523001 R21001 (Renewal and Extension Fund).



BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to prepare an appropriate contractual agreement for execution by the Mayor.

BE IT FINALLY RESOLVED, that this agreement shall not become binding on the City and the City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to AATC.



