

AN ORDINANCE AUTHORIZING THE MAYOR TO GRANT A PERMANENT CONSTRUCTION AND MAINTENANCE EASEMENT TO THE GEORGIA POWER COMPANY, FOR THE INSTALLATION AND MAINTENANCE OF THE ELECTRICAL DISTRIBUTION SYSTEM ALONG THE CORRIDOR OF NORTHSIDE DRIVE AND BISHOP STREET IN LAND LOT 151 OF THE 17TH DISTRICT OF FULTON COUNTY, GEORGIA TO ACCOMMODATE THE WIDENING AND IMPROVING OF THE INTERSECTION BY THE GEORGIA DEPARTMENT OF TRANSPORTATION; AND FOR OTHER PURPOSES.

WHEREAS, Georgia Power Company has requested a permanent construction and maintenance easement on City owned property; located in Land Lot 151 of the 17th District of Fulton County, Georgia, for the purpose of moving an existing electrical distribution system along this corridor to accommodate the widening and improving of the intersection of Northside Drive and Bishop Street by the Georgia Department of Transportation; and

WHEREAS, Georgia Power Company will be responsible for the payment of all costs associated with the construction, maintenance and installation of the electric distribution system; and

WHEREAS, a permanent construction and maintenance easement is required to install the electrical distribution system in Land Lot 151 of the 17th District of Fulton County, Georgia.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA:

Section 1

That the Mayor be and is hereby authorized to grant a permanent construction and maintenance easement to the Georgia Power Company for installation and maintenance of the electrical distribution system in Land Lot 151 of the 17th District of Fulton County, Georgia.

Section 2

That the Mayor is hereby authorized to execute an easement in favor of the Georgia Power Company across certain City owned property



described in Exhibit "A" attached hereto and made a part hereof by reference, for the purpose of accommodating the electrical distribution system.


Section 3:

Dear Mr. Ravan:

On June 18th, I had the opportunity of briefly discussing the above mentioned project with Dorsey Walker who asked me to submit the proper documentation to the Utilities Committee for review in your next meeting.

As you may already know, the Georgia Department of Transportation is currently in the process of widening and improving the intersection of Northside Drive and Bishop Street. As a result, Georgia Power Company (GPC) has been asked to relocate their electrical distribution system along this corridor, just outside of the newly expanded road right of way.

A distribution system is a service supply of energy for area homes and businesses. The easement will be, once in place, fifteen feet wide as a measured along the center conductor. The distribution poles are wooden, 18" in diameter, 40' foot tall and treated with Pena-Chlorinol.

Upon my inspection of your property, the Department of Transportation has already torn away the road bed and has graded the site for paving. Current GPC poles have been left in the middle of the intersection. If these poles are not relocated the electrical system may collapse or interrupt service to the neighboring residents. Additionally a few trees need to be trimmed so to not interfere with the conductors.

On Parcel No: 003, six (6) existing poles need to be relocated on Bishop Street and Northside Drive. Due to the fact some of these points are angle points, four poles will need down guys behind the pole, which will extend approximately 15 feet. Those pole locations are 7, 11, 13, and 126. See attached blueprint for reference. On Parcel No: 015, three (3) existing poles need to be relocated on Northside Drive. These pole locations are 21, 123, and 129. See attached blueprint for reference.

On the blueprints, the green highlight exhibits the old conductors and will be removed. The red highlights exhibit the new conductors and will be installed. The yellow highlights exhibit the property lines.






