### VOLUNTEER AREAS OF INTEREST

Please describe in a 100 words your interest in the litter prevention, beautification, community improvement, or minimizing the impact of waste in Atlanta's neighborhoods.

#### Litter Prevention:

- My daily routine has always included a morning jog/run throughout my neighborhood. Beginning about 6 years ago, and continuing through to the present, I began picking up the litter along my exercise routes. When I moved to Midtown I was amazed at the lack of trash barrels in the neighborhood. Working with condominiums and business owners, I have so far been successful in securing 9 additional trash barrels for the area. I have contacted numerous absentee owners about the litter surrounding their rental buildings

#### Beautification:

- I have served as a volunteer working with the Piedmont Park Conservancy as a "sweat" volunteer and to eliminate crime "hot spots".
- "Street Spam signs nailed to posts in my neighborhood are targets I have gone after with vigor.
- I am currently organizing, with the Midtown Neighbors Association, a Spring cleanup day.

#### Community Improvement:

- Co-founder, and President of the Midtown Ponce Security Alliance, a non-profit organization that raises the funding to pay for off-duty APD police officers to patrol the Midtown neighborhood. We have raised more that \$100,000 to support this program in our first year of operation.
- I convinced a Decatur church to discontinue their vagrant feeding program at the corner of 5<sup>th</sup> St. and Juniper.
- Brought together the Piedmont Park Conservancy, the Norfolk Southern Rail Road, and the APD to eliminate a vagrant camp in Piedmont Park.
- Currently organizing the Norfolk Southern and the Atlanta Solid Waste folks to eliminate two additional vagrant camps along the proposed Beltline.
