Gordon, Inc., for FC-7622-03, Inmate Dental Services in an amount not to exceed One Hundred Twelve Thousand Five Hundred Sixty Dollars and No Cents (\$112,560.00).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer be and is hereby directed to prepare an appropriate contractual agreement to be approved by the City Attorney, as to form for execution by the Mayor.

BE IT FURTHER RESOLVED, that this contractual agreement shall not become binding on the City, and the City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to the contracting party.
