A RESOLUTION BY THE ATLANTA CITY COUNCIL OPPOSING HB 882 SUBSTITUTE WHICH REMOVES THE THREE YEAR WAITING PERIOD FOR MODIFICATIONS CURRENTLY REQUIRED FROM THE DATE ANY SOLID WASTE FACILITY COMMENCED OPERATION; AND FOR OTHER PURPOSES.

WHEREAS, the State of Georgia Code Section 12-8-24 relates to permits issued for solid waste or special solid waste handling, disposal, or thermal treatment technology facilities and inspection of solid waste generators; and

WHEREAS, Georgia Code Section 12-8-24 paragraph (1) (e) includes the following language "All modifications of existing permits to allow vertical or horizontal expansion of existing disposal facilities, except a facility operated by a utility regulated by the Public Service Commission, shall be classified as major permit modifications and shall not be granted by the director sooner than three years from the date any facility commenced operation; provided, however, that a permit may be modified by the director to allow a vertical or horizontal expansion one time within three years from the date the facility commenced operation so long as the capacity of the facility is not increased more than 10 percent"; and

WHEREAS, HB 882 would amend Georgia Code Section 12-8-24 paragraph (1) (e), by deleting the following language "and shall not be granted by the director sooner than three years from the date any facility commenced operation; provided, however, that a permit may be modified by the director to allow a vertical or horizontal expansion one time within three years from the date the facility commenced operation so long as the capacity of the facility is not increased more than 10 percent"; and

WHEREAS, the City Council does not support amending the Georgia Code Section 12-8-24 paragraph (1) (e) as indicated in HB 882.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the City of Atlanta is in opposition TO HB 882.

BE IT FINALLY RESOLVED, that the Municipal Clerk is hereby directed to forward a copy of this resolution to the Governor, Lieutenant Governor and all members of the 2004 Georgia General Assembly.
