**A RESOLUTION TO SUPPORT SB 425 WHICH  
EXEMPTS FUNDS SPENT ON INTERSTATE  
HIGHWAYS FROM CONGRESSIONAL  
BALANCING REQUIREMENTS.**

**WHEREAS, SB 425** proposes to exempt spending on interstate highways from congressional balancing requirements which would otherwise serve to prevent adequate funds from being spent to relieve traffic congestion in the metro Atlanta area; and

**WHEREAS,** interstate highway construction in metro Atlanta is substantially more expensive mile-for-mile than construction in rural areas; and

**WHEREAS,** metro Atlanta's traffic congestion will be solved by effective interstate development plans lower cost to tax payers while targeting metro Atlanta highways for expansion and extension.

**NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA,** as follows:

**Section 1:** That the 2004 Georgia General Assembly is urged to support **SB 425**.

**Section 2:** That the Municipal Clerk is hereby directed to forward copies of this Resolution to the Governor, Lieutenant Governor and all members of the 2004 Georgia General Assembly.
