A RESOLUTION TO SUPPORT RESTORING FULL FUNDING TO THE HAZARDOUS WASTE AND SOLID WASTE TRUST FUNDS IN THE FY 2005 STATE BUDGET.

WHEREAS, the proposed FY 2005 state budget does not fully fund either the hazardous Waste Trust Fund or the Solid Waste Trust Fund; and

WHEREAS, residents of the City of Atlanta have been paying into the two funds for years and have a right to expect that their monies will be spent as promised; and

WHEREAS, several of the sites in Georgia requiring remediation are located in the City of Atlanta.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2004 Georgia General Assembly is urged to restore full funding for the Solid Waste Trust Fund and the Hazardous Waste Trust Fund.

Section 2: That the Municipal Clerk is hereby directed to forward copies of this Resolution to the Governor, Lieutenant Governor and all members of the 2004 Georgia General Assembly.
