A RESOLUTION TO OPPOSE ANY ATTEMPT TO REMOVE OPERATIONAL AUTHORITY OVER HARTSFIELD-JACKSON INTERNATIONAL AIRPORT FROM THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, several pieces of legislation have been introduced which would transfer operational authority and control over Hartsfield-Jackson International Airport away from the City of Atlanta; and

WHEREAS, under the City of Atlanta's authority, Hartsfield-Jackson International Airport has flourished and become the economic engine for the Southeastern United States and beyond; and

WHEREAS, the State of Georgia has not demonstrated proficiency or experience in operating an airport the size of Hartsfield-Jackson, nor is there any compelling reason whatsoever to believe that any other governance structure would be more effective

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2004 Georgia General Assembly is urged to oppose any legislation transferring operating authority for Hartsfield-Jackson International Airport from the City of Atlanta.

Section 2: That the Municipal Clerk is hereby directed to forward copies of this Resolution to the Governor, Lieutenant Governor and all members of the 2004 Georgia General Assembly.
