AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT A GRANT FROM THE ATLANTA REGIONAL COMMISSION FOR THE PURPOSE OF THE CITY PREPARING A LIVABLE COMMUNITIES INITIATIVE (LCI) STUDY FOR THE UPPER WESTSIDE PROJECT FOR THE HOME PARK COMMUNITY; AND AUTHORIZING THE MAYOR TO SIGN A GRANT AGREEMENT WITH THE ARC FOR THE STUDY; AND BY ANTICIPATING AND APPROPRIATING \$93,750. IN THE 2004 INTERGOVERNMENTAL GRANT FUND; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has prepared five LCI studies for various communities within the City; and

WHEREAS, the Atlanta Regional Commission has requested that the City prepare a LCI study for the Home Park Community to be named the Upper Westside LCI; and

WHEREAS, the Atlanta Regional Commission has provided the City a grant of \$75,000. to prepare this study; and

WHEREAS, the Home Park Community Improvement Association, Inc. has committed to provide the required 20% match directly to the Atlanta Regional Commission for this project in the amount of \$18,750; and


WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the Intergovernmental Fund by \$93,750.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the 2004 Intergovernmental Grant Fund is hereby amended as follows:
