BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE

AN ORDINANCE AMENDING THE 2004 (INTERGOVERNMENTAL GRANT FUND BUDGET, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF FOUR HUNDRED THIRTEEN THOUSAND, FIVE HUNDRED FORTY SIX AND NO/100 \$413,546 FOR THE PURPOSE OF A PILOT WELLNESS AND FITNESS PROGRAM TO IDENTIFY AND IMPLEMENT BEST PRACTICES FOR INITIATIVES TO REDUCE THE RISK OF INJURIES AND DEATH FOR FIRE SERVICE PERSONNEL.

WHEREAS, The Atlanta Fire Department recognizes that its greatest asset are the well trained men and women sworn to protect the citizens and visitors of this city and to minimize the loss of property; and

WHEREAS, The Atlanta Fire Department recognizes the extreme cardiac shock posed by the firefighting profession which requires personnel to go from a complete state of rest to extreme physical exertion within seconds of an alarm bell's first ring; and

WHEREAS, according to the National Fire Protection Association, in 2001, forty (40) firefighters died from heart attacks that were caused by overexertion or stress; and

WHEREAS, The Atlanta Fire Department has designed a comprehensive Wellness and Fitness Program to address the contributing factors that lead to cardiac, respiratory and muscular impairments and related risks; and

WHEREAS, The Atlanta Fire Department applied and received a grant award from the Federal Emergency Management Agency, U. S. Fire Administration Assistance to Firefighters Grant Program in the amount of \$413,546 to implement a mandatory Wellness and Fitness Pilot Program; and

WHEREAS, The Atlanta Fire Department developed the said program to identify and implement best practices for wellness and fitness programs as a model for fire personnel throughout the county and metropolitan area; and

WHEREAS, The grant funds will be used to purchase exercise equipment for each fire station, the training academy and headquarters, contractual/consultant services for health screenings, medical oversight and job task analysis functions, and general office supplies.


