WHEREAS, the D.T. Howard Facility would be an ideal location for Police Zone Five Criminal Investigations Division Decentralization,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into a Lease Agreement with the Atlanta Public Schools, for rental of 5,561 square feet of office space located at the D.T. Howard Facility, Atlanta, Georgia, for the Atlanta Police Department Zone Five Criminal Investigations Division Decentralization, beginning May 1, 2004, until April 30, 2005, in the amount not to exceed \$1,286.13 a month (\$15,433.56 a year), said payment to be charged to and paid from account number 1A01 525001 X42005.

BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to prepare an appropriate contract for execution by the Mayor or her designee, to be approved by the City Attorney as to form.


