To Whom It May Concern:

Due to the resignation of the Council President, Cathy Woolard, on April 26, 2004 and the subsequent resignation of the president pro tempore, Councilmember Derrick Boazman, effective April 28, 2004 at 12:59 PM pursuant to the Charter and the Code of Ordinances of the City of Atlanta, the succession will be as follows:

Councilmember Ceasar Mitchell will assume the position of president pro tempore and he shall preside until the Council President shall be duly elected and sworn in. As president pro tempore, he shall discharge the duties and exercise the powers and authority of the president.

As set forth in Section 2-36(e) of the Code, "in the absence of the president pro tempore, the president shall appoint any member of the Council to preside in the president's absence." Therefore, Councilmember Mitchell, as president pro tempore, will discharge this duty and exercise the powers and authority of the president by appointing a member of council to preside.

Upon the swearing in of a duly elected Council President, Councilmember Mitchell will continue to serve as president pro tempore for the duration of the annual term of 2004. As of January 2005, Councilmember Mary Norwood shall become president pro tempore, in accordance with the line of succession of the City Council.
