AN ORDINANCE AMENDING THE 2004 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE BY ANTICIPATING AND APPROPRIATING FUNDS IN THE AMOUNT OF \$250,000.00 FROM THE UNITED STATES DEPARTMENT OF JUSTICE FOR THE PROJECT SAFE NEIGHBORHOODS PROGRAM TO REDUCE GUN VIOLENCE IN THOSE NEIGHBORHOODS SURROUNDING SPELMAN COLLEGE; AND FOR OTHER PURPOSES.

WHEREAS, the U. S. Department of Justice has awarded the Atlanta Police Department a grant to be used to reduce gun violence in known high crime Atlanta neighborhoods, and

WHEREAS, the Atlanta Police Department has partnered with Spelman College public safety personnel to provide additional directed patrols and public education to prevent gun violence on campus and in the neighborhoods surrounding the college, and

WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing anticipations and appropriations in the amount of \$250,000 in response to this grant award.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA
