AN ORDINANCE TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO PAY THE COSTS ASSOCIATED WITH THE SPECIAL RUNOFF ELECTION FOR ATLANTA BOARD OF EDUCATION DISTRICT 2 HELD ON NOVEMBER 25 2003.

WHEREAS, Ordinance 03-O-1335 authorized the Mayor to enter into a contract with the Fulton County Department of Registrations and Elections for the purpose of conducting a special election, and if necessary, a runoff election, to fill a vacancy on the Atlanta Board of Education for District 2; and

WHEREAS, the timing of such special election coincided with a general election to be held on November 4, 2003; and

WHEREAS, the contract stated that the City's anticipated obligation for both the runoff and the special election would be \$3,740 for each election, which represented the additional cost to print the ballots for the voting district comprising Atlanta Board of Education District 2; and

WHEREAS, the amount calculated as necessary to fund the costs of the Board of Education runoff election was based on the premise that such runoff election would also be held in conjunction with a runoff for the general election; and

WHEREAS, no runoff was necessary for any office except the Board of Education seat for District 2; and

WHEREAS, the Fulton County Department of Registrations and Elections incurred certain expenses in connection with holding the runoff election in excess of the amount specified in Ordinance 03-O-1335 and has submitted an invoice, which is attached to this ordinance.

The City Council of The City of Atlanta Georgia, Hereby Ordains:

Section 1: That the Chief Financial Officer is directed to pay to the Fulton County Board of Registrations and Elections an amount not to exceed sixty eight thousand, two hundred and ninety-eight dollars (\$68,298) less any amounts previously disbursed in payment of this debt from Account Number 1A01 561001 T3001 for the payment of the costs stated in the attached invoice.

Section 2: That this payment shall be made not later than thirty days (30) after this ordinance is approved by the Mayor or becomes effective by operation of law.
