A RESOLUTION BY

COMMITTEE ON COUNCIL

A RESOLUTION DECLARING ATLANTA CITY COUNCIL DISTRICT 12 SEAT VACANT; AUTHORIZING THE MUNICIPAL CLERK TO PURSUANT TO ATLANTA CITY CODE SECTION 2-37 (1) ADVERTISE SAID VACANCY AND THE DESIRE OF THE COUNCIL TO TEMPORARILY FILL SUCH VACANCY (2) DEVELOP AN APPLICATION AND RELATED FORMS; (3) PROVIDE APPLICATION TO INTERESTED PERSONS UPON REQUEST; (4) RECEIVE COMPLETED APPLICATIONS AND FORWARD THEM TO THE COMMITTEE ON COUNCIL, AND TO UNDERTAKE ANY OTHER SUCH DUTIES AS ARE NECESSARY TO ASSIST THE COUNCIL IN TEMPORARILY FILLING THE COUNCIL DISTRICT 12 VACANCY UNTIL A SUCCESSOR IS ELECTED; AND FOR OTHER PURPOSES.

WHEREAS, the elected representative of the City of Atlanta Council District 12 Seat has resigned his elected office and there is consequently a councilmember vacancy in Council District 12; and

WHEREAS, it is therefore necessary to temporarily fill the Council District 12 vacancy until a successor is elected by special election on Tuesday, July 20, 2004 or if necessary by Special Run-off Election on August 10, 2004; and

WHEREAS, the governing authority of the City, the Atlanta City Council will select by majority vote an individual to temporarily fill the Council District 12

WHEREAS, pursuant to Atlanta City Code Section 2-37, the Municipal Clerk shall advertise the vacancy and the Council's desire to temporarily fill it, develop the necessary application forms, provide the application to interested persons and transmit completed applications to the Committee on Council.



NOW THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby resolves as follows:

SECTION 1: The Office of City Council District 12 Seat is hereby declared vacant.

SECTION 2: In accordance with the provisions of Atlanta City Code Section 2-37, the Municipal Clerk shall advertise the Council District 12 Seat vacancy and the Council's desire to temporarily fill it, develop the necessary application forms, provide the application to interested persons and transmit completed applications to the Committee on Council.

SECTION 3: That any persons interested in filling the temporary vacancy in the office of Councilmember for District 12, until a successor is elected in the July 20, 2004 City of Atlanta Special Election or in an August 10, 2004 Special Run-off Election, can apply for the vacancy by completing a required application in the City of Atlanta's Office of Municipal Clerk at Atlanta City Hall, 55 Trinity Avenue, Suite 2700 on Wednesday May 5, Thursday May 6, Friday May 7, Monday May 10 or Tuesday May 11, 2004, between the hours of 8:30 a.m. and 5:00 p.m. each day.

SECTION 4: The deadline for filing applications shall be 5:00 p.m. on Tuesday May 11, 2004.

SECTION 5: That the Council intends to receive all completed applications at a Special Called Meeting on May 12, 2004, and at that time from the floor of Council, individual council members may also nominate persons to fill the vacant Council District 12 Seat.

SECTION 6: That any Council floor nominees shall complete the required application forms subsequent to their nomination and that the Municipal Clerk shall forward all floor nominees completed application forms to the Committee on Council immediately upon receipt.

SECTION 7: That the Council intends to select by majority vote, at its next Regularly Scheduled Council Meeting on May 17, 2004, a temporary replacement councilmember for the vacant Council District 12 Seat to serve until a successor is elected at the July 20, 2004 City of Atlanta Special Election or at the August 10, 2004 City of Atlanta Special Run-off Election.

SECTION 8: That upon election by Council, the person designated to serve as a temporary replacement councilmember for the vacant Council District 12 Seat shall be immediately sworn in and assume the business of the people of Council District 12 and the City of Atlanta.
