AN ORDINANCE TO AMEND SECTION 30-1405 VENDING DISTRICTS AND LOCATIONS, OF ARTICLE XXIII. VENDING ON PUBLIC PROPERTY, SO AS TO ADD ONE (1) ADDITIONAL VENDING SPACE IN DISTRICT NO. 5, 6 FIVE POINTS; TO BE DESIGNATED AS 5-6 SPECIFICALLY FOR A DISABLED VETERAN; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has adopted a Public Vending policy; and

WHEREAS, included in this policy are Vending on Public Property guidelines; and

WHEREAS, these guidelines designate certain vending locations for blind persons, disabled and disabled veterans; and

WHEREAS, the income from these vending locations are of paramount importance to these classes of citizens; and

WHEREAS, the post-September 11th slump in the economy has adversely affected all businesses, especially the abovementioned classes; and

WHEREAS, it is the desire of the Atlanta City Council to add an additional space to lessen the impact on disabled veterans.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That Section 30-1405 (5)(a) of Article XXIII, which reads:

(5) District no. 5, Five Points.

Locations 5-1, 5-2, 5-3, 5-4 and 5-5. The west side of Peachtree Street from Alabama Street to Wall Street (five locations, with two reserved for disabled individuals, disabled veterans or blind persons).

Be amended to add an additional space (5-6) to be designated as a disabled veteran space, so that when amended Section 30-1405 (5) (a) shall read:

(5) **District no. 5, Five Points.**

a. **Locations 5-1, 5-2, 5-3, 5-4, 5-5 and 5-6. The Westside of Peachtree Street from Alabama Street to Wall Street (six locations, with two reserved for disabled individuals, disabled veterans or blind persons, and one (5-6) to be specifically designated for a disabled veteran).**

Section 2: That the numbered locations that follow subparagraph (a) reflect the addition of a new location through renumbering as follows:

b. Locations 5-7, 5-8, 5-9 and 5-10. The north side of Alabama Street from Peachtree Street to Forsyth Street (four locations).

c. Locations 5-11, 5-12 and 5-13. The east side of Forsyth Street from Alabama Street, north 100 yards (three locations, with one reserved for a disabled individual, disabled veteran or blind person).

d. Locations 5-14 and 5-15. The east side of Peachtree Street from Ellis Street, south 100 yards (two locations).

e. Location 5-16. The northeast corner of Peachtree Street and Auburn Avenue (one location).

f. Location 5-17. The southwest corner of Park Place and Auburn Avenue (one location).

g. Locations 5-18, 5-19, 5-20, 5-21 and 5-22. The east side of Peachtree Street from Auburn Avenue to Edgewood Avenue (five locations).

h. Location 5-23. The west side of Park Place between Auburn Avenue and Edgewood Avenue (one location).

i. Location 5-24. The northwest corner of Park Place and Edgewood Avenue (one location).

j. Location 5-25. The northwest corner of Park Place and Auburn Avenue (one location).

k. Locations 5-26, 5-27 and 5-28. The southwest corner of Forsyth Street and Carnegie Way (three locations, one on Forsyth and two on Carnegie Way; includes one location reserved for a disabled individual, disabled veteran or blind person).

l. Location 5-29. The southwest corner of Broad Street and Alabama Street (one location).

m. Location 5-30. The south side of Alabama Street between Peachtree Street and Broad Street (one location reserved for a disabled individual, disabled veteran or blind person).

n. Location 5-31. The northwest corner of Martin Luther King, Jr. Drive and Broad Street (one location).

o. Location 5-32. The northeast corner of Broad Street and Martin Luther King, Jr. Drive (one location).

p. Locations 5-33, 5-34, 5-35 and 5-36. The south side of Marietta Street in the Five Points MARTA station plaza (four locations, two locations reserved for disabled individuals, disabled veterans or blind persons).

Section 3: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
