AUTHORIZING THE MAYOR OR HER DESIGNEE TO ACCEPT ON BEHALF OF THE ATLANTA FIRE - RESCUE DEPARTMENT THE DONATION OF A VACANT RESIDENTIAL STRUCTURE (EXCLUDING LAND) VALUED AT \$260,000.00, LOCATED AT 962 GLEN ARDEN WAY, NE (VIRGINIA HIGHLANDS) BY MR. HELMI NEMO FOR THE PURPOSE OF FIREFIGHTER HANDS-ON TRAINING.

WHEREAS, Atlanta Fire-Rescue has the responsibility for properly training its firefighters; and

WHEREAS, Atlanta Fire-Rescue must attain vacant structures to enhance the instruction of its members on methods and techniques of forcible entry, ventilation, search and rescue and firefighter survival; and

WHEREAS, the above-mentioned citizen has agreed to donate the structure to enhance firefighter training for instruction exclusive of live fire activities; and

WHEREAS, the donation of this structure will assist the fire department in the instruction of its members only after any necessary asbestos abatement has been completed; and

WHEREAS, the removal of any debris and remaining structure after training is completed will be the responsibility of the landowner and donor.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

SECTION 1: The Mayor or her designee allows the Atlanta Fire-Rescue Department to accept the vacant structure located at 962 Glen Arden Way from Mr. Helmi Nemo for the purpose of firefighter training in order to continue to improve the delivery of its essential service to the citizens of Atlanta.

SECTION 2: That all resolutions and parts thereof in conflict herewith are hereby repealed.
