A RESOLUTION AUTHORIZING THE MAYOR OR DESIGNEE TO ISSUE A NOTICE-TO- PROCEED WITH KISSBERG CONSTRUCTION COMPANY, INC. FOR FC-7382-01, ANNUAL CITYWIDE CONTRACT FOR DEMOLITION SERVICES TO PROVIDE DEMOLITION FOR SMO AND REMOTE RECEIVER, ON BEHALF OF THE DEPARTMENT OF AVIATION IN AN AMOUNT NOT TO EXCEED FIFTY TWO THOUSAND TWO HUNDRED TWENTY ONE DOLLARS AND NINETY NINE CENTS (\$52,221.99). ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND ACCOUNT AND CENTER NUMBER: 2H30 (2004 AIRPORT REVENUE BOND FUND) 574001 (FAC OTHER THAN BUILDING) R21E0126 93CK (EASTSIDE TERMINAL AMOUNT) (\$44,388.69) 2H30 (2004 AIRPORT REVENUE BOND FUND) 574001 (FAC OTHER THAN BUILDING) R21E0126 93CL (EASTSIDE TERMINAL NON-AMOUNT) (\$7,833.30).

WHEREAS, the City of Atlanta (the "City") did enter into FC-7382-01, Annual Citywide Contract for Demolition Services; and

WHEREAS, the General Manager of the Department of Aviation requires Demolition Services in the amount not to exceed Fifty Two Thousand Two Hundred Twenty One Dollars and Ninety Nine Cents (\$52,221.99); and

WHEREAS, the General Manager of the Department of Aviation and the Chief Procurement Officer for the Department of Procurement have recommended Kissberg Construction Company, Inc. to provide Demolition Services.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to approve a notice-to-proceed with Kissberg Construction Company, Inc. for FC-7382-01, Annual Citywide Contract for Demolition Services; in the amount not to exceed Fifty Two Thousand Two Hundred Twenty One Dollars and Ninety Nine Cents (\$52,221.99).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer be and is hereby directed to prepare an appropriate agreement for execution by the Mayor to be approved by the City of Atlanta as to form.

BE IT FURTHER RESOLVED, that this notice-to-proceed should not become binding on the City, and the City shall incur no liability upon same until such contract has been executed by the Mayor and delivered to the contracting party.

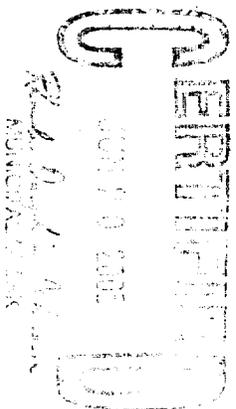
