AN ORDINANCE TO ANTICIPATE AND APPROPRIATE GRANT FUNDS IN THE AMOUNT OF \$24,100,000.00 FROM THE FEDERAL AVIATION ADMINISTRATION AND TRANSFER TO AND FROM APPROPRIATIONS IN THE AMOUNT OF \$6,025,000.00 FOR THE CITY'S SHARE IN GRANT AGREEMENT 3-13-0008-67, TO ACQUIRE LAND FOR NOISE COMPATIBILITY WITHIN 70-74 DNL; AND FOR OTHER PURPOSES

WHEREAS, the City of Atlanta owns and operates the William B. Hartsfield Atlanta International Airport; and

WHEREAS, the Federal Aviation Administration (FAA) hereby announces its intentions, in accordance with the provisions of Title 49, United States Code, to obligate funds from future budget authority to issue grants to pay the City of Atlanta, for the United States share of allowable costs at the Hartsfield Atlanta International Airport for the project described as Acquire Land for Noise Compatibility within 70-74 DNL; and

WHEREAS, the City entered into grant agreement AIP 3-13-0008-67 with the Federal Aviation Administration for a total of \$30,125,000.00; and

WHEREAS, the contribution of the Federal Aviation Administration is for a total of \$24,100,000.00 (80%) and the City's share being \$6,025,000.00 (20%); and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That the 2005 Airport Renewal and Extension Fund Budget, Department of Aviation Land Acquisition Compatibility/Relocation, be and hereby is amended as follows:


