AN ORDINANCE TO AMEND SECTION 2-1877 OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA GEORGIA, SO AS TO CHANGE THE PROCEDURE BY WHICH APPOINTMENTS ARE MADE BY COUNCILMEMBERS TO THE KEEP ATLANTA BEAUTIFUL COMMISSION; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

IT IS HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: Section 2-1877 of the Code of Ordinances of the City of Atlanta, Georgia, which currently provides as follows:

“Appointment of members.

The members of the clean city commission may make nominations of prospective members of the clean city commission to the city councilmembers. Each city councilmember shall, in the councilmember's discretion, select three individuals who are residents of the councilmember's district or combined districts if the councilmember is at large. Each list shall be submitted to the mayor who from those lists shall appoint 15 commission members representing each council district within the city. The mayor shall, in the mayor's sole discretion, appoint all remaining commission members except two who shall be appointed by the city council president. All appointments of members to the commission must be confirmed by the city council. The commission shall be known as Keep Atlanta Beautiful.”,

is hereby deleted in its entirety with the following being substituted in lieu thereof;

“Appointment of members.

The 27 members of the Keep Atlanta Beautiful Commission shall be appointed as follows and said appointments shall be confirmed by the city council:

- (a) Ten (10) members shall be appointed by the mayor;
- (b) Two (2) members shall be appointed by the president of council;
- (c) Fifteen (15) members shall be appointed by the city council as follows: Each city councilmember shall appoint one (1) individual who is a resident of the councilmember's district or combined districts if the councilmember is at large.



The members of the Keep Atlanta Beautiful Commission may make recommendations to the mayor, president of council, and councilmembers, of prospective members to be appointed to the Commission.”

Section 2: All ordinances or parts of ordinances in conflict herewith are hereby repealed.


