AN ORDINANCE TO TRANSFER \$1,248.39 FROM DISTRICT FIVE (5) COUNCILMEMBER SIDEWALK WAIVER ACCOUNT TO THE DEPARTMENT OF PUBLIC WORKS TO BE USED SPECIFICALLY FOR SIDEWALK INSTALLATION AT 2053 RIDGEDALE ROAD, SE; AND FOR OTHER PURPOSES.

WHEREAS, the District 5 council member and the Kirkwood community have identified the use of sidewalk waiver funds; and

WHEREAS, funds are available in the 5th District council person's sidewalk waiver account for this purpose; and

WHEREAS, the council member and the Department of Public Works have decided that the work needed (sidewalk installation) can be done by the department; and

WHEREAS, the citizens and the city of Atlanta will benefit from this work and it will provide all citizens with the safety and benefits of sidewalks in the community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived in this instance only.


