WHEREAS, often the limitation of time has constricted the Council from making significant progress; and

WHEREAS, as a policymaking body, the City Council, the Council should be involved in strategic policymaking for the city; and

WHEREAS, this should be done in conjunction with, and sometimes, independent of, the Executive branch; and

WHEREAS, this process should involve the review of strategic plans, as well as the development and setting of priorities for the City's governance; and

WHEREAS, the Council's committee schedule precludes much of this type of detail; and


WHEREAS, the Code of Ordinances of the City of Atlanta authorizes the City Council to take three (3) recesses annually; and

WHEREAS, these recesses seem an opportune time to hold such retreats.
