**WHEREAS**, the citizens and residents of the neighborhood surrounding Collier Drive, NW feel that traffic in the area necessitate restricting parking on a segment of this street; and

**WHEREAS**, designating both sides of Collier Drive, NW from Bolton Road to Fairburn Road, NW "No Parking Anytime" would accomplish this.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE  
CITY OF ATLANTA** as follows:

**SECTION 1:** That both sides of Collier Drive, NW from Bolton Road to Fairburn Road, NW be designated "No Parking Anytime".

**SECTION 2:** That appropriate signage identifying the affected portion of the street be installed.

**SECTION 3:** That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
