ZEIGLER JETER, MPA RPH IN AN AMOUNT NOT TO EXCEED \$37,500.00 (THIRTY SEVEN THOUSAND FIVE HUNDRED DOLLARS) TO PERFORM PHARMACEUTICAL SERVICE ON BEHALF OF THE DEPARTMENT OF CORRECTIONS AT THE ATLANTA CITY DETENTION CENTER. ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND, ACCOUNT AND CENTER NUMBER 3P02 524001 I21W02CL9999, TRUST FUND, CONSULTANT ACCOUNT, INMATE WELFARE FUND.

WHEREAS, the City of Atlanta did solicit Request for Proposals for qualified consulting firms for FC-7493-02, Inmate Pharmacy Services to perform pharmaceutical service at the Atlanta City Detention Center; and

WHEREAS, Patricia L. Zeigler Jeter, MPA, RHP was awarded said contract with an Agreement that contained an option to renew for two (2) additional one year periods; and

WHEREAS, the Chief of the Department of Corrections and the Chief Procurement Officer have recommended that a Renewal Agreement No. 2 be executed for a period of one (1) year.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that the Mayor be and hereby authorized to execute Renewal Agreement No. 2 , FC-7493-02, Inmate Pharmacy Services with Patricia L. Zeigler Jeter, MPA, RPH to perform pharmaceutical service at the Atlanta City Detention Center in an amount not to exceed \$37,500.00.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer be and is hereby directed to prepare said Renewal Agreement No. 2 for execution by the Mayor to be approved as to form by the City Attorney.

BE IT FURTHER RESOLVED, that said Renewal Agreement No. 2 shall not become binding on the City of Atlanta and the City of Atlanta shall incur neither liability nor obligation hereunder until the same has been signed by the Mayor and delivered to the contracting party.

BE IT FINALLY RESOLVED, that all contracted work shall be charged to and paid from Fund, Account and Center Number 3P02 524001 I21W02CL9999, Trust Fund, Consultant Account, Inmate Welfare Fund.
