A RESOLUTION AUTHORIZING THE RE-EMPLOYMENT OF CITY RETIREE ELLIS COLBERT AS AN INFORMATION TECHNOLOGY MANAGER SENIOR FOR THE CITY OF ATLANTA DEPARTMENT OF WATERSHED MANAGEMENT, PURSUANT TO § 3-505(C) OF THE CHARTER OF THE CITY OF ATLANTA, TO BE PAID FROM ACCOUNT AND CENTER NUMBER 2J01 511003 Q71101 (SALARIES, EXTRA HELP – CUSTOMER SERVICE/ADMINISTRATIVE SUPPORT); AND FOR OTHER PURPOSES.

WHEREAS, Ellis Colbert retired in good standing as an Information Technology Manager for the City of Atlanta Department of Information Technology on August 22, 2004; and

WHEREAS, The Charter of the City of Atlanta §3-505(c) authorizes that the City of Atlanta may re-employ a retiree for any single period of time, or any several periods of time, which shall not exceed 520 business days, whether continuously or in separate days of employment, for the purpose of availing the City of some skill possessed by said retiree; and

WHEREAS, Mr. Colbert possesses specialized information technology skills and knowledge of water utility billing systems, the Watershed data base and business processes; and

WHEREAS, The City of Atlanta Department of Watershed Management is undertaking to acquire and implement a new utility billing system; and

WHEREAS, The City of Atlanta Department of Watershed Management desires to retain the services of Mr. Colbert in a position of Information Technology Manager, Senior to assist with that conversion and implementation; and

WHEREAS, The City of Atlanta Department of Watershed Management and Mr. Colbert have mutually agreed to his re-employment as an Information Technology Manager, Senior.

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA:

SECTION 1: That the Atlanta City Council is authorized to re-employ Mr. Ellis Colbert as Information Technology Manager, Senior at Salary Range 30, Step 10 (Salary \$76,556), as provided under the Charter of the City of Atlanta §3-505(c), to be paid from Fund Account and Center Number 2J01 511003 Q71101 (Salaries, Extra Help – Customer Service/Administrative Support).

SECTION 2: That all resolutions and parts thereof in conflict herewith are hereby rescinded.
