**SECTION 1.** All Sections of the Atlanta Zoning Ordinance are hereby amended by deleting all sections in their entirety, which reads as follows:

..... churches, synagogues, temples..... etc.

**SECTION 2.** And new Sections of the Atlanta Zoning Ordinance are hereby enacted, which shall read as follows:

..... churches, synagogues, temples, mosques..... etc.

**SECTION 3.** All ordinance or parts of ordinances in conflict with this ordinance are hereby repealed.
