AN ORDINANCE TO AMEND CHAPTER TWO, ARTICLE IV, SECTION 2-195, OF THE CODE OF ORDINANCES TO EFFECT REORGANIZATION OF THE EXECUTIVE BRANCH BY TRANSFERRING CERTAIN TECHNOLOGY FUNCTIONS OF THE OFFICE OF COMMUNITY TECHNOLOGY TO THE ATLANTA WORKFORCE DEVELOPMENT AGENCY; TO TRANSFER CERTAIN INVENTORY PROPERTY FORMERLY IN THE POSSESSION OF THE OFFICE OF COMMUNITY TECHNOLOGY TO THE ATLANTA WORKFORCE DEVELOPMENT AGENCY; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, Charter Section 3-301(a) of the City Code prescribes that "The departments of the city shall be created and established by ordinance;" and

WHEREAS, Charter Section 3-302 of the City Code empowers the Mayor, as the chief executive of the city, to initiate, direct and implement a reorganization of the Executive Branch by ordinance submitted to the City Council for approval; and

WHEREAS, the Atlanta Workforce Development Agency ("AWDA") is an integral part of City government with the purpose of administering employment and training programs mandated under the Workforce Investment Act (WIA) of 1998 to the citizens of Atlanta and to offer workforce solution services to metro Atlanta businesses; and

WHEREAS, the functions and duties of AWDA should be codified within the executive branch of city government; and

WHEREAS, the Office of Community Technology ("OCT") is no longer operational; and

WHEREAS, for efficiency, the Mayor wishes to transfer certain duties of the Office of Community Technology to the AWDA.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY
ORDAINS AS FOLLOWS:**



Section One: That Chapter Two, Article IV of the Code of Ordinances of the City of Atlanta be amended by deleting existing Section 2-195 in its entirety and substituting the following:

Section 2-195 Functions and duties of the Atlanta Workforce Development Agency.

The functions and duties of the Atlanta Workforce Development Agency shall include:

- (1) Administering employment and training programs mandated under the Workforce Investment Act (WIA) of 1998 to the citizens of Atlanta;
- (2) Offering workforce solution services to metro Atlanta businesses;
- (3) Providing a single point of entry for Workforce Information by bringing businesses, job seekers, and training providers together to provide skilled workers for every business and employment for every job seeker in the City of Atlanta; and
- (4) Providing management, support, and direction to the city's initiative to bring computer technology to all citizens by working with government and private sector funding sources related to technology.

Section Two: That the inventory of OCT, consisting primarily of desktop computers and related equipment, be transferred to the use and control of AWDA in furtherance of the AWDA's responsibilities as set out in Section One above.

Section Three: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
