ENDORING AND SUPPORTING THE ATLANTA HOST COMMITTEE'S BID FOR SUPER BOWL XLIII (IN THE YEAR 2009); AND FOR OTHER PURPOSES.

WHEREAS, the National Football League ("NFL") owns, produces, and controls the annual professional football championship game known as the "Super Bowl", the largest national annual sporting event held in the United States, and NFL Properties, Inc. owns, produces, and controls the "NFL Experience" and other certain events hosted by NFL Properties associated with the Super Bowl (Official Events"); and

WHEREAS, the Atlanta Host Committee is preparing a bid for the City of Atlanta to host Super Bowl XLIII in the year 2009; and

WHEREAS, the City of Atlanta cooperated as a full partner during Super Bowl XXVIII (in 1996) and Super Bowl XXXIV (in 2000); and

WHEREAS, the City of Atlanta has within its jurisdiction facilities and their premises, access roads, thoroughfares, and other areas which may be used for the purposes of organizing, financing, promoting, accommodating, staging, and conducting Super Bowl XLIII and its related Official Events and activities; and

WHEREAS, hosting Super Bowl XLIII and its associated Official Events will generate good will, enhance the worldwide renown and prestige of the City of Atlanta, lead to the creating of temporary jobs, and create substantial beneficial economic and fiscal activity for the City; and

WHEREAS, the NFL has requested a declaration of support from the City of Atlanta in connection with Super Bowl XLIII and related Official Events as part of the formal bid made by the Atlanta Host Committee to be designated as a site for Super Bowl XLIII; and

WHEREAS, the City of Atlanta now wishes to express its support for the bid by the Atlanta Host Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that the City of Atlanta welcomes Super Bowl XLIII and related Official Events to its jurisdiction and to that end declares its support of the efforts of the Atlanta Host Committee to have the City of Atlanta and the Georgia Dome selected as the site for Super Bowl XLIII.
