TO AMEND CHAPTER 154 ARTICLE III, DIVISION 3 (WATER RATES, CHARGES AND RELATED MATTERS) SECTION 154-111 AND 154-112 ARTICLE V, DIVISION 3 (SEWER RATES, CHARGES AND RELATED MATTERS) SECTION 154-276 AND 154-277 OF THE CODE OF ORDINANCES SO AS TO CHANGE THE INCOME THRESHOLD FOR THE WATER AND SEWER RATES WAIVER FROM \$25,000.00 TO \$35,000.00; AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

**SECTION 1:** That Chapter 154, Article III Division 3 (Water Rates, Charges and Related Matters) Section 154-111 and 154-112 be amended by deleting the amount twenty-five (\$25,000.00) dollars and inserting **THIRTY-FIVE THOUSAND (\$35,000.00) DOLLARS**

**SECTION 2:** That Chapter 154, Article V Division 3 (Sewer Rates, Charges and Related Matters) Section 154-276 and 154-277 be amended by deleting the amount twenty-five (\$25,000.00) dollars and inserting **THIRTY-FIVE THOUSAND (\$35,000.00) DOLLARS**

**SECTION 3:** That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
