**AN ORDINANCE AMENDING THE 2005 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$5,400,000 FOR GRANT FUNDS FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY FOR CONTINUATION OF THE HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA) TASK FORCE AND CONTINUE DISRUPTION OF DRUG TRAFFICKING ORGANIZATIONS, AND FOR OTHER PURPOSES**

**WHEREAS**, the Atlanta Police Department has been an active participant in the High Intensity Drug Trafficking Area (HIDTA) task force for the past ten years, and

**WHEREAS**, the White House Office of National Drug Control Policy grants funding to local task forces responsible for disrupting and dismantling violent drug trafficking organizations, and

**WHEREAS**, these federal funds require a ‘pass through’ agency to disburse payments for task force expenses that are completely federally funded, and

**WHEREAS**, the Georgia Bureau of Investigation has acted as ‘pass through’ agency for this program but has opted to no longer do so, and

**WHEREAS**, the Atlanta Police Department has been selected to serve as the ‘pass through’ agency in place of the GBI, and


**WHEREAS**, federal grant funds to fund task force operations will now be awarded to the Atlanta Police Department,

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**
