AN ORDINANCE AUTHORIZING THE MAYOR TO DESIGNATE THE EAST SIDE OF PEACHTREE STREET NORTHEAST, BETWEEN NORTH AVENUE AND LINDEN AVENUE, AS A NO PARKING ZONE EXCEPT SUNDAYS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") has been petitioned by the North Avenue Presbyterian Church ("Church"), located at 607 Peachtree Street, to designate the east side of Peachtree Street, between North Avenue and Linden Avenue, as a NO PARKING EXCEPT SUNDAYS zone; and

WHEREAS, the Church was utilizing a parking lot located at 615 Peachtree Street for over-flow parking until the building at this address was demolished, thereby removing the Church's access to over-flow parking; and

WHEREAS, the volume of traffic is minimal on Sundays and the installation of NO PARKING EXCEPT SUNDAYS signs will not have a major impact on traffic movement; and

WHEREAS, the Commissioner of the Department of Public Works has recommended that the east side of Peachtree Street, between North Avenue and Linden Avenue, be designated as a NO PARKING EXCEPT SUNDAYS zone.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:

SECTION 1: That the Mayor is authorized to designate the east side of Peachtree Street, between North Avenue and Linden Avenue, as a NO PARKING EXCEPT SUNDAYS zone.

SECTION 2: That the Department of Public Works, Office of Transportation, install appropriate signage.

SECTION 3: That all ordinances or parts of ordinances in conflict with this are hereby waived.




