**AN ORDINANCE AMENDING THE 2007 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS, IN THE AMOUNT OF SEVENTY SEVEN THOUSAND EIGHT HUNDRED NINETY DOLLARS (\$77,890.00), FOR GRANT FUNDS FROM THE GOVERNOR'S CRIMINAL JUSTICE COORDINATING COUNCIL, FOR THE PURPOSE OF PAYING FOR OVERTIME TO POLICE OFFICERS PATROLLING GANG AREAS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta's ("City") Department of Police ("Department") recognizes that gang related violence is a growing problem within the Bowen Homes Community and the surrounding areas; and

**WHEREAS**, in the year 2006, the Department reported that gangs were responsible for thirty-one (31) assaults and robberies and eighty-six (86) gun arrests; and

**WHEREAS**, the Department, in conjunction with Department of Justice Project Safe Neighborhoods program, has implemented a multifaceted gang reduction strategy to reduce gang related violent crime; and

**WHEREAS**, based on areas identified by Tactical Crime Analysis, the Department implemented direct patrols and surveillance in areas known as hot spots for violent gang crime; and

**WHEREAS**, Department also used paid overtime for personnel assigned to the Gangs and Guns Unit and Patrol Zone One, which includes the Bowen Homes Community; and

**WHEREAS**, the Governor's Criminal Justice Coordinating Council has awarded the Department a grant, in the amount of seventy seven thousand eight hundred ninety dollars (\$77,890.00) for the purpose of paying for overtime to police officers providing additional patrols in areas frequented by gangs; and

**WHEREAS**, the Department recommends increasing anticipations and appropriations in the 2007 (Intergovernmental Grant Fund) Budget, Department of Police, in the amount of seventy seven thousand eight hundred ninety dollars (\$77,890.00).

**1. Please provide a summary of the purpose of this legislation (Justification Statement).**

The purpose of this legislation is to amend anticipations and appropriations of the 1B02 Intergovernmental Grant Fund to account for a grant award of \$77,890.00 from the Governor's Criminal Justice Coordinating Council. The grant will be used by the Atlanta Police Department to pay for overtime incurred by officers providing additional patrols in areas frequented by gangs, and also for training in dealing with illegal gangs.

**2. Please provide background information regarding this legislation.**

This grant is part of a larger anti-gang initiative organized by Project Safe Neighborhoods. Analysis of crime in Atlanta has shown a significant amount is perpetrated by members of illegal gangs. This grant pays for overtime worked by police officers providing additional patrols in areas frequented by gangs, and also for training in dealing with illegal gangs.


