AN ORDINANCE TO CORRECT THE CENTER NUMBER IN ORDINANCE NUMBER 06-O-1617 ADOPTED BY THE ATLANTA CITY COUNCIL ON SEPTEMBER 5, 2006 AND APPROVED BY THE MAYOR ON SEPTEMBER 13, 2006; AND FOR OTHER PURPOSES.

WHEREAS, ordinance 06-O-1617 amended the 2006 (Intergovernmental Grant Fund) Budget by adding to anticipations and appropriations in the amount of \$1,542,491.00, and was adopted by the Atlanta City Council on September 5, 2006 and approved by the Mayor on September 13, 2006; and

WHEREAS, ordinance 06-O-1617 identified the incorrect center number in Section 1 entitled "Add To Appropriations"; and

WHEREAS, the Department of Finance and the Atlanta Workforce Development Agency are in agreement with the ordinance being corrected to reflect the correct center number.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

Section 1: That center number Y71X0201JBUB in **Section 1** of ordinance 06-O-1617 is hereby corrected to read as follows: Y71R0331JBUB.

Section 2: That all existing ordinances or parts of ordinances in conflict with this ordinance shall be waived for the purposes of this Ordinance only, and only to the extent of the conflict.
