

**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE AMENDING THE FY08 (TRUST FUND) BUDGET FOR THE CITY OF ATLANTA MUNICIPAL COURT, COMMUNITY COURT DIVISION (“COMMUNITY COURT”), BY ADDING A DONATION IN THE AMOUNT OF TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00), FROM THE BOARD OF DIRECTORS OF THE COMMUNITY COURT/RESTORATIVE JUSTICE CENTER, INC., FOR THE PURPOSE OF SUPPORTING THE OPERATING COSTS OF THE NON-PROFIT ORGANIZATION WITHIN COMMUNITY COURT; AND FOR OTHER PURPOSES.

WHEREAS, the Municipal Court of Atlanta created the Atlanta Community Court Foundation (“Foundation”) in January 2004 to assist in the funding of the Community Court service programs; and

WHEREAS, since the Foundation’s creation, the Board of Directors and Staff have been successful in obtaining grants and donations to fund innovative alternative sentencing programs; and

WHEREAS, the Board of Directors of the Community Court/Restorative Justice Center, Inc. would like to donate twenty-five thousand dollars (\$25,000.00) to the Community Court for the purpose of supporting the operating costs of the non-profit organization within Community Court; and

WHEREAS, the Department recommends increasing anticipations and appropriation in the FY08 (Trust Fund) Budget, Municipal Court, Community Court Division; and

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the FY08 (Trust Fund) Budget, Municipal Court, Community Court Division, is hereby amended as follows:


